眼睛接触 Eye contact	万一接触，立即用大量的清水冲洗至少15分钟，翻起上下眼睑，直到化学的残留物消失为止，迅速就医。 Flush eyes with plenty of water for least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.
皮肤接触 Skin contact	万一接触，用大量的水冲洗至少15分钟，同时除去污染的衣物和鞋子，迅速就医。 Remove contaminated clothes and rinse skin with plenty of water or shower for 15 minutes. Get medical aid.
吸入 Inhalation	立即从暴露处移至空气清新处，如果呼吸困难给予输氧，立即就医。 Remove from exposure and move to fresh air immediately. Use oxygen if available.
摄入 Ingestion	饮用两杯牛奶或水，如果当事人仍然清醒可以采取催吐的方法，并且立即就医。 Give at least 2 glasses of milk or water. Induce vomiting unless patient is



unconscious. Call a physician.

Section 6- Accidental Release Measures

个人预防措施、保护设备和应急程序:

如果电池被泄露, 让人员离开该区域直到烟雾消散。提供最大限度的通风, 清除有害气体。首选的反应就是离开这个地区并消散气体, 避免皮肤和眼睛接触或吸入气体。用吸收剂清除溢出的液体然后焚烧。如果电池泄漏发生时, 液体可以用砂、泥土或其他惰性物质来吸收, 污染区域应该保持通风。

Personal precautions, protective equipment and emergency procedures:

If the battery is released, remove personnel from area until fumes dissipate. Provide maximum ventilation to clear out hazardous gases. The preferred response is to leave the area and allow the vapors to dissipate, Avoid skin and eyes contact or inhalation of vapors. Remove spilled liquid with absorbent and incinerated. If leakage of the battery happens, liquid could be absorbed by using sand, earth or other inert substance and contaminated area should be ventilated meantime.

Environment precautions:

Do not allow product to reach sewage system or any water source.

如果电池外壳被拆除, 少量电解液可能会泄漏。收集所有材料放进一个塑料容器。根据当地的法律法规来处置, 避免可溶物质进入大地、下水道或水源。

Methods and material for containment and cleaning up:



If battery casing is dismantled, small amounts of electrolyte may leak. Collect all released material in a plastic lined container. Dispose off according to the local law and rules, Avoid leached substances to get into the earth, canalization or waters.

The battery should not be opened, destroyed or incinerate, since they may leak or rupture and release to the environment the ingredients that they contain in the hermetically sealed container.

Do not short circuit terminals, or over charge the battery, forced over-discharge, throw to fire.

Do not crush or puncture the battery, or immerse in liquids.

储存 Storage

Do not place the battery near heating equipment, nor expose to direct sunlight for long periods.
